A fascinating series of talks started with **Professor Tamas Szekely** (University of Bath, right) discussing the significance of male to female ratios in the development of breeding systems shown in animals.



This was followed by an absorbing presentation by **Professor Henrike Lähnemann** (University of Oxford) on the hymnbooks of the reformation (left).

Professor Michael Häusser FRS (University College London, right) presented the many insights gained from his group's work on probing neural circuits.



After a very enjoyable lunch and the Annual General Meeting of the Association, **Dr Ian Maclaren** (University of Glasgow, left) gave his lecture. In this very engaging talk, he revealed how the analysis and understanding of chemical processes on earth and in space could be probed using high resolution spectroscopy.

The first of two *Brian Ketterer lectures* was given by **Professor Martin Loughlin** (London School of Economics), who led a fascinating discussion of the British constitution from the viewpoint of German political science.
